About Conservation Districts

Conservation districts were born out of necessity in the 1930's Dust Bowl when America's topsoil rapidly eroded. At that time, Congress declared soil and water conservation a top priority, leading to the birth of conservation districts.

In 1945, Pennsylvania state legislators recognized the need to support grass-roots conservation efforts. As a result, the [Conservation District Law](#) was passed, and county conservation districts were created. Today there is a conservation district established in every Pennsylvania county except Philadelphia.

Across Pennsylvania, conservation districts help local communities use natural resources wisely.

Conservation districts implement a variety of programs, and provide assistance for a range of issues unique to their county.
