### **District Employees Committee Survey (Sandy Thompson)**

Sandy Thompson reported that the District Employees Committee discussed having outreach to educators or an administrative "boot camp." They also talked about how to reach non-traditional groups such as urban agriculture. The committee is putting together a survey to send to districts.







### **Staff Evaluations**

Lehigh County Conservation District is reviewing the staff performance evaluation process. They developed a new set of questions along with an individual development plan to maximize their employee potential. They want to focus on the results from the employee not the activity. It was suggested to share this though the manager's listerve.

### **Increasing Participation in Envirothon**

Allegheny County Conservation District's Envirothon program has really diminished. Teachers don't have time and funding for buses. Pike County has a lot of participation. The key is finding one teacher in the school who will push it in the school. The paenvirothon.org website is a great resource teachers can use. If there is a former student who loved the program, have them come back and talk to the kids about their Envirothon experience.
