Kinzua Bridge State Park Visitor Center and Park Office

Visitor Center Details

The new visitor center and park office will provide a location for visitors to interact with staff and explore the history of the viaduct. The building will be heated geo-thermally. By using sustainable materials, reducing water use, and decreasing waste production during construction, we hope to earn LEED (Leadership in Energy and Environmental Design) Certification.

The \$6,900,000 project which began in 2014 is expected to be completed sometime during the summer of 2016. A grand opening event will be scheduled, but a date has not yet been determined.

Once completed the center will be opened year-round with proposed hours of 8 a.m. to 4 p.m. Monday through Friday and seven days a week operation during peak season - Memorial Day through the end of October. Please remember the park itself is open year-round from 8 a.m. to sunset daily. There is no charge to enter the park, walk on the skywalk or go through the exhibits.

Kinzua Bridge was originally built in

Why We Are Special

1882 and being over 301 feet high and 2,053 feet long it was the tallest and longest railroad bridge in the world!

On July 21, 2003 an F1 tornado struck the middle section of the bridge, throwing the towers to the ground. The towers that remained now have an added deck on the end with a partial glass floor. The Kinzua Skywalk awaits visitors who want to continue to experience the breathtaking views of the valley!



Building Features

The Kinzua Bridge State Park Visitor Center and Park Office features a reception area, gift shop, and spectacular view of the nearby skywalk. Modern restrooms are available. Benches will be nearby providing the visitor a chance to relax.

The new building boasts a total of 11,000 sq. ft. which includes exhibit areas of 1147 sq. ft. upstairs and 1110 sq. ft. downstairs. The exhibits focus on the themes of engineering, environment, energy and history as they relate to the structure and the local area. Some of the exhibits are “hands on” for the enjoyment of our younger visitors, while others entail the use of exciting artifacts and videos for all ages.

An 874 sq. ft. classroom ideal for motor coach or school groups (up to 70 people), features a divider thus giving the option to convert it into two smaller classrooms. A deck wraps around the outside of the classroom for all visitors to view the skywalk and valley.

In the future the conference room and classroom will be available for reservations.

The building is friendly to visitors with disabilities with an accessible restroom near the entrance and an elevator that can be used to go from the first floor exhibit level to the ground level. The lower level doors open with a walkway that will allow the visitor to go directly to the skywalk.

Recreational Opportunities

PICNICKING: The picnic area has shaded picnic tables. Modern restrooms are within walking distance in the visitor center. A picnic pavilion that seats 60 people is accessible to people with disabilities. The pavilion can be reserved. Please see rental information near the bottom.



HIKING: 1.5 miles

General Kane Trail: 1.09 miles, easiest hiking

The trail wanders through hardwood forests of black cherry and maple trees, including areas both ravaged and renewed by nature itself since the 2003 tornado. Many species of club mosses and a variety of wildlife species can be seen along the trail.

Kinzua Creek Trail: 0.4 mile (one way), most difficult hiking

Construction of this switchback trail is still ongoing and provides access to the bottom of the gorge. This steep, challenging trail gives close-up views of the piers for the skywalk and spectacular views of the fallen towers. **Entering the debris field is prohibited.** Hikers must retrace their steps back to the trailhead. Hikers are advised to wear appropriate footwear for this trail.

HUNTING AND FIREARMS: About 100 acres of the park are open to hunting, trapping, and the training of dogs during established seasons. Common game species are deer, bear, turkey, and grouse. Hunting is prohibited from the skywalk. Adjacent State Game Lands 62 is open to hunting with over 8,000 acres.

Use extreme caution with firearms at all times. Read and follow all hunting and firearms rules and regulations posted on the Bureau of State Parks' website. www.visitPAParks.com

Programming Opportunities

Most programs will cover the themes of engineering, the environment, energy, and history of the area. Other topics may be covered per request. For special programming requests, please call the park office at (814) 778-5467. Visit www.dcnr.state.pa for information on currently scheduled programs.

SCHOOL GROUPS: With our focus on the themes of the building, it is no wonder that most of our programs are **STEM** (Science, Technology, Engineering & Math) related! Programs correlate to PA Standards and vary in length. We have "Day Packages" for teachers who would like their class to spend the majority of the day at the park or we have individualized programs for classes that have limited time. Some programs can begin in the group's classroom at school with a follow-up field trip to the park. We have a separate brochure that lists some of the programs/packages offered or if you have a specific topic in mind, please call the park to inquire about availability. **Home School Groups** are encouraged to inquire about these programs as well.

MOTOR COACH GROUPS: We are motor coach friendly! The bus may drive directly to the entrance of the building to drop off the group. While the driver parks the bus in the bus/rv only parking area, the group can use the modern restroom facilities in the building. The group will have the opportunity to go through the exhibits both upstairs and downstairs, take a walk out on the skywalk, and then back to the building to peruse the gift shop and second chance for a restroom stop. The bus driver can then bring the bus back to the front of the building to pick up the group.

OTHER GROUPS: This includes scouts, 4-H, church, or other community groups that would like to visit the park and would like to have an opportunity to learn more with a program.

SPECIAL DAYS: The third weekend in September is our popular Kinzua Bridge Fall Festival. This event has vendors, music, and a whole lot of fun! Stop by and enjoy it!

VOLUNTEERS: The park is always looking for volunteers to help in the many different aspects of the park and the building. If you are interested in volunteering, please contact us!

**Proposed PACD Bylaws Amendment
– Region Director Eligibility –
*Amended***

The membership reviewed a proposed PACD Bylaws amendment, which would allow an Associate Director to serve as PACD Region Director, during the Fall 2016 PACD Region Meetings.

However, the PACD South West Region proposed an amendment to the proposal, which was not reviewed by the other five regions. Below is new language that reflects the amendment proposed by the PACD South West Region.

ARTICLE VIII – REGION DIRECTORS

Section 1. Election of Region Directors

Each PACD Region will elect a District Director **or Associate Director** in good standing to serve as Region Director. **Any Associate Director elected to serve as Region Director must be officially appointed as an Associate Director by their Conservation District’s Board of Directors, on an annual basis, from that point forward.**

Each Conservation District in good standing in attendance at its respective PACD Region Meeting shall have one vote, which shall be cast by a certified Voting Delegate of the Conservation District. If more than one candidate is seeking election, the election shall be by secret ballot. A candidate shall be elected by a simple majority.

The Region Director will serve a term of two years and may be re-elected. Elections will take place at the PACD Region Meeting after the PACD Annual Meeting in odd-numbered years.



PACD Bylaws Conflict Voting Rights of PACD Executive Board Members

Summary

An amendment to the PACD Bylaws is needed to clarify voting rights for PACD Executive Board members, in the case that there is more than one board member from the same conservation district.

The Conflict

According to the *PACD Bylaws, Article V, Section 1*, in the event that there are two or more PACD Executive Board members from the same conservation district, only one of those individuals may vote.

According to the *PACD Bylaws, Article VI, Section 1*, PACD Executive Board members each have one vote at all PACD Executive Board meetings.

These two items are in apparent conflict with one another.

The Decision before the Membership

In the event that there is more than one board member from the same district on the PACD Executive Board, does the membership wish that:

- a. each of these board members should have a vote
- b. only one of them should have a vote

If the region chooses:

- a. then, the language in red under Article V should be struck from the Bylaws
- b. then, the language in red under Article VI should be struck from the Bylaws

ARTICLE V – EXECUTIVE BOARD

Section 1. Membership

The officers of the PACD and the six Region Directors shall constitute an Executive Board which may, at the call of the President, meet between Executive Council Meetings to act on behalf of the PACD. The National Association of Conservation Districts Director shall serve as an ex-officio non-voting member of the Executive Board. **Each Conservation District represented on the Executive Board shall have one vote; and in the event any Conservation District shall be represented by more than one person (for example, by more than one officer or by an officer and a Region Director), such Conservation District shall determine and shall advise the Secretary which person shall have the right to vote.**

A simple majority of the membership of the Executive Board shall constitute a quorum for the purpose of conducting the business of the meeting.

ARTICLE VI – VOTING

Section 1. Voting

Each Conservation District shall have one vote at PACD Region Meetings and Executive Council meetings which shall be cast by its Voting Delegate, or by an Alternate Voting Delegate, selected and certified on behalf of the Conservation Districts as provided below. To be entitled to vote, the Conservation District must be in good standing by having paid its dues during the previous PACD fiscal year; provided upon a showing of extenuating circumstances by a Conservation District, the Executive Board, at its discretion, may permit a late payment or waive all or part of the unpaid dues.

Executive Board members shall each have one vote at all Executive Board meetings.

Those persons identified as being members in Article II, Section 1 shall have no voting rights unless they serve as members of the Executive Board, or unless they are Voting Delegates or Alternate Voting Delegates certified to vote on behalf of a Conservation District.

Affiliate Members have no voting rights.
