Welcome and Introductions

Set Date for Next Meeting

The next meeting was set for Tuesday, October 23, 2018, at 10:00 a.m. at the Cumberland County Conservation District office.

Approval of Minutes

The minutes of the previous meeting of October 17, 2017, were provided for review.

Motion by Wilbur Wolf to approve the minutes as presented. Second by Jack Dehoff. Motion carried.

PACD Business and Report

A meeting with DEP Deputy Secretary Tim Schaeffer has been scheduled for May 7 at 10:00 a.m. at the Cumberland County Conservation District.

Brenda reported on several meetings – CCAP sessions, Districts 101 and what Districts are doing and funding activity with District programs. Several managers partnered on that presentation.

Brenda also discussed the Strategic Plan. There are seven priorities; ongoing efforts to implement them. It is key to improve relationships with partners, specifically PA DEP and State Conservation Commission (reference Brenda's Spring Region Meeting Report for details)

PACD Office Building

Should we keep, sell or seek another space? Maintenance issues, parking, roof replacement/repair (\$30,000.00 estimate). Feedback would be to stay close to Capitol, leasing



would relieve staff of work. Cost analysis of renting/leasing vs. owning was discussed. Value of PACD building at present is \$450,000.00. 3,500 square feet would be needed in new building and \$20.00/square foot is an estimate for rental. PACD hosts multiple meetings per year. The Executive Committee can't meet at PACD because of lack of parking space. We need to carefully consider the cost v. benefit of owning, renting or leasing. Parking spaces for lease or rent are not likely due to frequency. Successful ownership often involves tenant rent. USDA has office space available there now. If the decision is sell the PACD building, the proceeds from the sale would be invested.

Annual PACD Winter Meeting

A discussion was held on the necessity of holding a winter meeting and, if not, what other options might be available. Could we consider swapping the region meetings with the annual meeting? Are two statewide meetings per year necessary? Most of the folks felt it was important to continue winter meetings. February is a good time for staff and we should consider farm member availability.

Farm Show Support (booth)

PACD staff finds it a challenge every year to find volunteers to staff the booth. How much interaction with our clients/target audience occurs? We believe it is a limited amount. If we would not participate in Farm Show, what would be other alternatives? Could we have a display at the "Know Your Farmer" section? DCNR and NRCS are interested in partnerships with PACD for Farm Show.

Ag Progress Days

Feel this is a better audience as it consists of our clients.

Keystone Farm Show

This event is held in York and definitely draws more farmers. This show runs Tuesday, Wednesday and Thursday the same week as Farm Show.

PSATS

Not a lot of engagement at present. We need to examine how we are marketing Districts which would fall under the PACD Marketing Plan. If DGLVR is there, that would be important. We need to explore partnerships. April is a tough time for Districts to add more work/events to their schedules.

Conservation District Week (April 15-22)

This effort was very successful last year. PACD is asking all districts to do something that week. Visiting legislators is a worthwhile initiative. Brenda provided the districts a template for a Conservation District promo release—maybe work to obtain a Commissioner's Proclamation. This event corresponds with Earth Day. The districts need to invite legislators to events, i.e. in conjunction with Envirothon.

Budget

Funding for Conservation Districts is flat lined in the Governor's and House budgets. We need to let legislators know of issues. Brenda indicated that she expected the budget to be on time as this is an election year. A large number of legislators are retiring.

Staffing

Interviews are being scheduled to Somerset Office TAG Professional Engineer; Leadership Development Coordinator; and Program Manager.

Legislative Budget & Finance Committee Study

Chapter 102 & 105 – Districts will be included in the study and will be complete within the year.

Zimmerman Bill

Representative Zimmerman indicated that he is no longer planning on pursuing this legislation. Facts made the case that plans get approved more quickly that legislation requires (180 vs. 270 days).

No Managers' Summit in June; perhaps later in the year.

Partner Reports

DCNR

- \$250,000 Grant do to multi-functional buffers (3 years)
- PennVest Funding up to \$3,000,000 for grants over 3 years. Must pre-qualify do districts are now eligible through PACD?
- Relief NFWF grant \$380,000 and 7 county region
- Riparian Buffer hoping for gap funding or non-government funds. Funds through Western PA Conservancy \$4,000/acre, 3 year grants can fund maintenance
- Can share maps and lists of data for buffer sites. Several folks on staff are able to support CREP Riparian Buffers
- PACD 25 year agreement between landowners and district/PACD. Keep buffer in and maintain for 25 years. 15' average buffer. No match reimbursement
