- Tim Shaffer from DEP is willing to meet with districts once again to discuss concerns. Preliminary date set for May 31<sup>st</sup> 2018 at 10:00 AM at the Westmoreland Conservation District.
- Discussed the acceptance of the Strategic Plan (Handout).
- Gave advice to district managers for the highlights page given to legislators.
- 65 of 66 districts handed in their highlights page.
- Discussed Conservation Week events in April 2018.
- Inviting legislators to events would be better on Thursdays and Fridays. because of their obligation to be at the Capital during the early party of the week.
- Requested strengthening relationships between districts and our partners.
- Expect an earlier approved budget due to election year.



- House of Representatives are finishing up budget hearings, good amount of support being shown to Conservation Districts.
- Advertising for a Professional Engineer to fill vacancy at Somerset Tech. Office.
- Advertising for a Leadership Development Coordinator.
- \$250,000 grant awarded from DCNR for Riparian Buffers over the next 3 years.
- Mainly looking for multi-purpose buffers (walnut trees, blueberry bushes etc.)
- Karl Brown discussed a recent request passed by the Senate on permitting (handout provided). The study will be include the Conservation Districts permit review process and the DEP permit reviews. The Committee will be looking for ideas for improvement.
- Fred Fiscus briefly discussed House Bill 226 (handout provided)
- Brenda will be accepting comments and relaying them to the appropriate individuals.

#### Discussed the continuance of the PACD Winter Meeting

- Possibility of moving to only 1 state meeting.
- Possibility of moving to quarterly regional meetings to conduct business and voting.
- Possibility of just keeping the meeting going as before to help keep interaction between agencies going, but possibly integrating training into the meeting as well

- A recent spike in urban agriculture

#### **Armstrong County**

- The mobile environmental display is slated to visit 16 counties and the Joint Annual Conference, possible partnership with media station WQED
- Recently finished a stream reclamation project and working on installing a new passive AMD treatment system

#### **Beaver County**

- Seeing a gas well drilling increase due to new Shell cracker plant
- Looking to do a Conservation District week event that invites all legislators to do a meetand-greet with the public

#### Cambria County

- Transition from county employees to district employees going well
- Hired new staff members in November

- Looking forward to utilizing the new Leadership Coordinator to help with future planning

## **Indiana County**

- Conservation District Week activity is set for April 19<sup>th</sup> and includes a legislative breakfast
- Building a new office with a \$925,000 grant, making the building as "green" as possible and includes a 50 person meeting room to host events
- Recently awarded final approval to hire a watershed specialist
- 2 Ag projects going to construction very soon

## Somerset County

- Handout of 2017 Annual report
- 2 Oven Run AMD projects moving to construction, 2 more to be designed
- Looking at ways to improve ALD system in Lambertsville
- SLAC sponsored and event called "Lakefest" and a few days later the lake was drawn down to remove fish so the dam breast and spillway can be re-constructed

#### **Washington County**

- Moving into new office space which will house USDA and FSA possibly in July
- Working on 4 Growing Greener projects
- Doing a lot of pipeline work permit processing

## Westmoreland County

- Installing and Rehabbing retention basins funded by Growing Greener
- Doing an Engineer workshop on the 22<sup>nd</sup> and 23<sup>rd</sup> of March
- Americorps people are working out great, looking to hire more in the future
