TWENTY-SIX POLLUTION PREVENTION PROJECTS FUNDED

(Harrisburg) – Pennsylvania's County Conservation Districts were awarded nearly \$43,000 for twenty-six pollution reduction projects in twenty-six counties. These projects promote water pollution prevention activities through the Non-point Source (NPS) Pollution Prevention Educational Mini-Grant Program. The projects will take place over the next 8 months.

"Today, Pennsylvania's conservation districts received funding from the Pennsylvania Department of Environmental Protection for educational projects. These projects are held locally. They invite citizens to learn how they can make a difference to reduce pollution," said Brenda Shambaugh, Executive Director for the Pennsylvania Association of Conservation Districts (PACD).

Funding for the grants, up to \$2,000 each, is provided through the Pennsylvania Department of Environmental Protection under Section 319 of the Clean Water Act, administered by the US Environmental Protection Agency.
