2019 Feature Accomplishment



Reforesting Adams County Streams

Resource Challenge

Pennsylvania's Phase 3 Watershed Implementation Plan is driving the county to achieve pollutant reductions through the installation of riparian buffers and urban tree plantings.

Project Summary and Results

14+ acres of riparian buffers were installed by contractors at:

- Carroll Valley Borough Parks 5.25 acres along Toms Creek & Friends Creek
- Lake Heritage Property Owners Association 9.6 acres along Plum Run on association owned lots

6+ acres of riparian buffers were installed through ACCD's:

• Install & Educate Program – 750 trees and shrubs were planted on 4 school properties with students while learning the benefits of trees and buffers

Other Accomplishments

- Agricultural Best Management Practices (BMPs) installed: 7.7 miles of subsurface drainage, 1.54 miles of waterways covering 5.6 acres, 0.46 mile of underground outlet, 0.46 mile of terraces, 464 ft of diversions, 265 ft of spouting, and 2 sediment basins
- Performed 251 E&S inspections with 99% compliance
- Installed 21 acres of riparian buffers and contracted 20+ acres of riparian buffers and wildflower & native grass meadows for 2020.
- Dirt, Gravel, and Low Volume Roads completed 3 sites: 4 stream culvert replacements, 420 ft of underdrains, 650 ton of road fill added, 2800 ft of improved road surface
- Mosquito-borne Disease Program sites treated: 293
- Ticks collected to be analyzed for tick-borne diseases: 65 deer ticks, 88 dog ticks
- County students reached through environmental programs: 1,825+

Feature Accomplishment

Milk Run Abandoned Mine Water Treatment Plant



Milk Run, in North Fayette Township, has been polluted for over a century. The discharge was the single largest source of acidity and aluminum pollution in the Montour Run Watershed. An abandoned mine water passive treatment system will improve water quality and enhance an important resource for residents.

An AMD 5-pond passive treatment system will restore nearly a mile of stream by removing an estimated 72,000 pounds of acid and 7,000 pounds of aluminum per year.

Key Project Partners: Montour Run Watershed Association, Department of Environmental Protection, Stream Restoration Incorporated, and Independence Conservancy with funding from Range Resources, U.S. Office of Surface Mining, S. Kent Rockwell Foundation, and Foundation for Pennsylvania Watersheds

- Workshops: Water Quality Monitoring Workshop, Three Rivers Urban Soils Symposium, Erosion Control Workshop, Western PA Regional Soil Health Workshop, Manure Management Planning Workshops

2019 Feature Accomplishment



Our new Watershed Specialist, Hannah Schrauder, has hit the ground running. She has applied and received several grants this year, but the most fun project was the Cooney Hollow Stream Cleanup. Twenty-two volunteers attended, including several Boy Scouts, to help pick up trash in and along a tributary flowing next to Cooney Hollow Road in Economy Borough. They collected an estimated 30 tires, 20 TVs, and other miscellaneous items that had been dumped. Funding for this stream cleanup was provided by the Henry L. Hillman Foundation in conjunction with RiverWise. We also thank Economy Borough for their support.

Other Accomplishments

We hosted workshops on agricultural E&S, manure management, rain barrels and non-point source pollution, held a forestry field day for landowners, and received a Growing Green grant for a streambank project on Raccoon Creek.

In youth education and outreach, we had 29 teams participate in our county Envirothon and 766 students, teachers, and youth leaders attend wetland and watershed classes at our education facilities.



One of our major goals for 2020 is to increase our outreach to our municipalities and inform them of the resources we provide.



Bedford County Conservation District

During 2019, 13 road projects were completed in the County through the Dirt, Gravel and Low Volume Road Program, eight on unpaved roads and five on low volume paved roads, though some of these were initiated in prior years. Contracts for the work were with nine townships and the Pennsylvania Game Commission. Funds provided to the participants totaled about \$1.13 million.

The most expensive project addressed a slope failure along a road in Londonderry Township, first noticed as the guide rail began sliding down the slope in early Spring 2019. A geotechnical survey revealed failure under about 200 feet of roadway, threatening a tributary to Wills Creek and a railway. Work began in late October and was completed in early November.



Work Continues with Intergovernmental Stormwater Committee

Authorization was given to extend the governing body established to work regionally on stormwater implementation in Blair County. The District was again chosen to host the Stormwater Coordinator tthrough December 2023.

Specific to our MS4 area, the District initiated work on two grants promoting green infrastructure and water quality monitoring. Construction will begin in 2020 at Lakemont Park and PNG Field, home of the Altoona Curve Minor League Baseball Team!

Thanks to a generous County Allocation for 2019, the District serving the Ag Land Preservation Board, preserved 4 farms in 2019.

Blair County now has 55 farms totaling 8,133 acres permanently under conservation easements.

Bradford County Conservation District

2019 Feature Accomplishment



Project: Comprehensive Watershed Conservation in Dairy and Livestock Landscapes of the Chesapeake Bay – Bradford County Conservation District Regional Conservation Partnership Program(PA)

Main partners: Landowners, local contractors, BCCD, NRCS, NFWF, PADEP, Upper Susquehanna Coalition, Chesapeake Bay Foundation.

- 22 stream sites rehabilitated (1.86 miles of stream channel and 3.21 miles or riparian zone)
- 12 farm projects (111 Ag BMP's installed)
- 4 Dirt and Gravel road improvement projects
- Annual savings: 10,472,500 lbs. sediment, 36,800 lbs. Phosphorus, 87,500 lbs. Nitrogen

Other Accomplishments

Emergency Stream Intervention — An emergency permit pilot program for Bradford County included as part of BCCD's Chapter 105 Program. Thirty-eight attendees including municipalities, landowners and contractors attended a 3-day classroom and field-based training where they learned the fundamentals of emergency stream intervention and how the emergency permits would be utilized.

Main Partners: Bradford County Commissioners, PADEP, BCCD

American Eel Pilot Program – This program is to educate the community on the importance of eels and their relationship with native mussels in the Chesapeake Bay Watershed. This year 15 eels were transported from the Conowingo Dam to BCCD for observation and potential release in June 2020.

Main Partners: PA Fish & Boat Commission, BCCD, Susquehanna River Basin Commission, USGS Northern Appalachian Research Laboratory, and many more.

County Stream Initiative – This project is designed to protect, homes, wells, septic systems, barns, etc. within 50 feet of a stream. Applications are accepted and sites are ranked based on certain criteria. This year 10 stream bank stabilization projects were completed. Sediment reductions are estimated at 2,037 tons annually, which corresponds to annual Nitrogen and Phosphorus reductions of 5,095 lbs. and 2,037 lbs., respectively.

BCCD continued its SARE grant activities that allow them to study the effects of manure stacking on areas with a seasonal high-water table. Spotted Lanternfly Control

Through a grant from Pennsylvania Department of Agriculture, Bucks CCD was able to:

- Evaluate and scrape SLF egg masses over 150 acres in Central and Upper Bucks County
- Band and regularly monitor over 60 acres of native trees
- Remove 150 tree-of-heaven (Ailanthus altissima) trees
- Establish one (1) trap tree

Other Accomplishments

- Lake Luxembourg Conservation Pool Completed design and secured permits for a regional stormwater management project to significantly reduce nutrient and sediment pollution in Lake Luxembourg and Core Creek and create wetland habitat.
- SARE grant Analyzed data to study effects of manure stacking on groundwater.
- Dirt & Gravel/Low Volume Roads Program Three (3) Dirt & Gravel Projects totaling \$89,619.47 were funded in Tinicum Township and Haycock Township.
- Manure Management Outreach Presentations at Delaware Valley University's Equine Seminar, Intro to Soils Class, and Ag Waste Class.
- Watershed Outreach Twenty (20) outreach events reaching approximately 1,300 people on topics including nonpoint source pollution prevention, invasive species, lake and pond ecology and stormwater management.

2019 DGLVR Feature Accomplishment





Barr Township completed a Low Volume Road Project on Mountain Drive in June 2019 and utilized \$55,240.00 in DGLVR funds to fix the huge erosion problem that started on Kline Road. The Township decided to complete the work on Kline Road themselves and use that work as part of their in-kind contributions which totaled \$39,928.61. This work needed to be completed on both roads is because these roads snake up the steep hillside leaving the Township without means to get water off the roads without causing a huge erosion problem, such as the gully that was already created as shown in the "before" picture. The gully continued to erode and clog all the cross pipes on Mountain Drive, leaving the Township continuous work every time

it rains. Now that the work is completed, the Township has less

maintenance on both roads and sediment runoff was greatly

reduced to the West Branch of the Susquehanna River.

Other Accomplishments

Two Days of Family Fun

This year the District held two Family Day events. Day one was held at Duman Lake County Park, with kayaks, a fun game from the PA Game Commission, and a presentation featuring the ever-changing human/wildlife interactions. Day two was held at our environmental center with a theme dedicated all to bugs. We had 74 people of all ages participate in the events!



Streambank Stabilization Projects

The District completed eight streambank stabilization projects this year. The eight projects were: Cherry Tree Phase II, Glendale Shoreline Phase V, Northern Cambria Flood Control Phase II, Nanty Glo Phase II, Chest Creek Phase V, North Branch of Blacklick Creek, Laurel Lick, and West Branch of Blacklick Creek. All projects totaled \$394,221.


Sterling Run AMD Restoration

Project Summary: Converted pasture to a 17-acre Riparian Forest Buffer, protecting 3,600 linear feet of Slab Cabin Run. Also installed barnyard Best Management Practices (BMPs) at 3 animal facilities, including Roofed Manure Storage areas.

2019 Feature Accomplishment



In 2018, Clearfield County Conservation District received funds from the Western PA Conservancy for the installation of a low impact canoe/kayak launch to Chest Creek in Westover. After consistent high-water conditions throughout 2018, we were finally able to install the access in 2019. This gradual step design was installed at a location where the bank was eroding into the stream, thus stabilizing the streambank and preventing tons of sediment load into Chest Creek for years to come.

2019 Feature Accomplishment



Clinton County Dirt, Gravel and Low Volume Roads Project – Greene Township, Harbaugh Road.

This project was aimed at replacing an undersized, failing culvert that did not provide passage for aquatic life.

The existing culvert caused severe erosion at the outlet, had sediment deposits, and was a barrier for fish migration in a Class Atrout fishery. The culvert inlet was less than half of the width of the stream and had collapsed. An aluminum arch structure with a full plate bottom was constructed at bank-full width in order to accommodate high flows and restore the stream corridor. The new structure does not decrease the width of the stream.

In order to receive EWP funding, an eligible local sponsor must agree to coordinate the projects and payments. The Columbia County Conservation District voted to serve as sponsor for 13 projects in Columbia County that met the EWP criteria for funding. The criteria included flood erosion damage with a home or business located within 50 feet of a stream. The Columbia County Commissioners also provided title search support required before construction could begin.

Funding support of \$525,000 was received to complete 13 Columbia County projects to help safeguard the properties from flooding and erosion. 75% of project funds were from NRCS and 25% of project funds were from DEP.

The Herzing family contacted the Elk County Conservation District (ECCD) with concerns about the proximity of an eroding streambank to their camp. To preserve the integrity of the streambanks along the Herzing Camp property, ECCD replaced rip-rap with modified mudsill cribbing and installed root wad deflectors along a high, eroding bank for ~320ft. Funding for this project was through the Headwaters RC&D Council, Sinnemahoning Watershed Grant.



In 2019, the Conservation District was awarded just over \$749,000 through the Pennsylvania Growing Greener Grant Program to undertake the design and construction of an additional 4,000 feet of stream restoration work along Big Cove Creek. Combined with matching funds, this project is expected to total nearly one million dollars in environmental improvements to the ag-impaired stream. The project will involve three separate landowners and will take more than two years to design, permit, and construct.

Other Accomplishments

- For the 14th year, District and Bureau of Forestry staff provided hands-on, outdoor learning experiences at the DCNR Kerper Tract to 4th, 5th, and 6th grade students from McConnellsburg Elementary/Middle School.




Glen Oaks Streambank Stabilization Project Dennison Township, Luzerne County



This project included 300 feet of streambank stabilization approximately 40 feet high and removal of 160 feet of gravel bar, restoring a section of upper Nescopeck Creek to a clean, free flowing, Class A wild brook trout stream through a residential neighborhood. Besides the environmental benefits, the project will help alleviate the threat of catastrophic bank failure and future flooding impacts. It is estimated the stream will be spared from 92 lbs. of Nitrogen, 31.3 lbs. Phosphorus and 142,600 lbs. of Sediment each year. The \$237,368 project was funded through a Growing Greener grant. The District's partners included PA DEP, USDA NRCS, Chesapeake Bay Foundation, Penn State Extension Watershed Stewards, and Dennison Township.

Invasive Plant and Stream Crossing Inventories

District summer interns collected extensive data on invasive plant populations and stream crossings for aquatic organism passage potential. Their work was partially funded by National Fish & Wildlife Foundation grants (Pulling Together and Central Appalachia Habitat Stewardship Program). The data provides a baseline and helps plan for future plant treatment and crossing replacements; and will help to secure additional funding for this work. They utilized GIS based mobile applications and worked closely with the county GIS coordinator to compile the data. This field work helped both the Allegheny Plateau Invasive Plant Management Area partnership and the Dirt, Gravel, and Low Volume Road program. Grant funding was awarded in the fall from the PA Department of Agriculture (Rapid Response funds) to treat populations of plants posing significant ecological threats that were inventoried.

Environmental Education Programs

The 2019 McKean County Envirothon team, the Bradford Bees, placed fourth at the PA Envirothon. Each of the five team members were awarded scholarships for their accomplishment. This is the highest McKean County has achieved at the event. All District educational programs and events in 2019 reached over 3,200 people.

West Kane Low Volume Road Project

This project involved improving drainage for a road base made of mostly clay soils. We tmore Township replaced two poorly functioning cross-pipes with one new larger cross-pipe; installed 210 feet of underdrain; installed a 160 foot French mattress to help drain spring seeps in and around the road; and improved the road base.

Total amount funded by the grant was \$23,848.00 with \$20,825.38 contributed by the township.

2019 Feature Accomplishment

Resource Challenge:

The 2018 Pennsylvania Integrated Water Quality Monitoring and Assessment Report lists causes of surface water quality impairment to Montgomery County surface waters as agriculture, urban runoff/storm sewers, municipal point sources, thermal modifications and sources unknown. Sources of impairment (for fish consumption, recreational and aquatic life uses) include nutrients, siltation, pathogens, organic enrichment/low dissolved oxygen, PCBs, excessive algal growth and causes unknown.

Project Summary and Results:

With funding provided through the Southeast PA Tree Vitalize Watersheds grant program, MCCD partnered with several local watershed organizations, municipalities, academic institutions and volunteers to secure Landowner Agreements, develop Operation and Maintenance Plans and install 12 riparian buffer installation and/or enhancement projects across 23 acres. Through these projects, partners worked to plant and protect 2,093 native trees and 1,080 native shrubs along stream corridors and stormwater management facilities to help capture and treat runoff, reduce soil erosion, improve water quality, enhance aquatic and wildlife habitat conditions and provide educational opportunities for the public.

8th Lehigh Valley Watershed Conference



Northampton County Conservation District partnered with the Watershed Coalition of the Lehigh Valley and other planning members to present the 8th Lehigh Valley Watershed Conference. The Conference was held on October 15th, at Lehigh University in Bethlehem, PA. Over 170 attendees from varied backgrounds participated in sessions focusing on MS4 concerns, multifunctional riparian buffers and crops, regional planning and recreation, vegetation management, and other topics.



A 3-part barnyard project on a cow/calf operation, located in Upper Augusta Township. Project 1: the construction of a 106' -10^{3/4"} X 68' pole type roof installed over an existing heavy use area and new manure stacking area. Project 2: the construction of a 60' X 76' roofed concrete barnyard gave the landowner ample manure storage and bedding area. Project 3: included reinforced gravel cattle walkways and stream crossing and construction of grassed waterways below the culverts. A grassed waterway was installed at the base of a road culvert to address gully erosion that extended from the culvert to the crop field. Funded in part by a PA DEP Growing Greener Grant (\$156,108.47) and a Chesapeake Bay Special Projects Grant (CBSP) (\$108,323.00).

Coordinated and sponsored a Grass Management Field Day at the Daryl Eberly Farm in Elliottsburg, Pennsylvania to address soil health and water quality issues often associated with over-grazing. Eighty attendees learned about areas that need to be considered in pastures, current regulations involving pastures, animal nutrition, cover crop mixes (pictured above), and soil health. The day was finished with a pasture walk highlighting how grazing fits into the Eberly farm management system. In addition, the use of grazing sticks as a tool in pasture management was demonstrated and participants received a complimentary grazing stick from PACD. 2019 Feature Accomplishment - Burt Street Culvert Replacements





Outlet before (above left) and Inlet after (above right)

This headwaters tributary of the Genesee River had experienced degraded quality from failing road infrastructure. Burt Street, an unpaved road in Bingham Township, crosses the stream in two locations and interfaces with stream along the entire length. Collaboration by Bingham Township, Ulysses Borough, DCNR, the Potter County Conservation District, Center for Dirt and Gravel Roads, and Trout Unlimited partnered to implement a remediation strategy that restored favorable watershed conditions while enhancing road conditions. The two road stream crossings located on Burt Street were replaced in order to allow for aquatic organism passage and facilitate storm discharge to reduce flooding. The road was then stabilized with pervious aggregate to mitigate sediment contribution to the waterway. These techniques support an array of environmental benefits consistent with river conservation. The conservation-oriented infrastructure put in place during the course of this project allows for safe conditions for the public transit and is a long-term solution to frequent maintenance for both municipalities. The total cost of this project was just under \$177,000.00.

- Streambank erosion / habitat enhancement projects completed on five properties reducing sediment and saving property from washing away.
- A new canoe/kayak launch constructed on Pine Creek in Galeton that will provide recreational opportunities.
- Education and outreach to approximately 1981 adults/youth through 38 different events. Some of these events included a rotational grazing field day at a local beef/dairy farm, pesticide meeting, stream workshop, pollinator workshop, job shadowing and mock interviews, Envirothon, and other hands on field events.
- Assisted several landowners in obtaining emergency permits from DEP due to flooding events.
- Permit approval and project oversight on over 8 large scale sites including: Big Level Wind Project, Sheetz store (Coudersport), new State Police Barracks, AT&T tower (Roulette), UGI, West Penn Power, FM100, and P40 pipeline projects.




