Minutes of Previous Meeting

Resolutions from PACD Committees

Resolutions from the PACD Region Meetings

- Policy on Proposed Amendment to the Clean Streams Law
The resolutions from the PACD region meetings were provided for review. Five regions voted to support the original proposed policy from the PACD Legislative Committee, which was developed in response to proposed legislation to amend the Clean Streams Law to allow municipalities and administrative agencies of the Commonwealth to require streambank fencing for livestock. The PACD South West Region proposed an amended version of the policy, which supports allowing administrative agencies, but not municipalities, to require fencing along a stream. Only one of the following policies may be adopted by Council.
 - PACD recognizes the significant environmental benefit of streambank fencing in a pasture used for grazing to restrict livestock access to the stream. PACD supports education and incentives for voluntary installation of streambank fencing as opposed to legislation allowing administrative agencies of the Commonwealth and municipalities to require fencing along a stream.
