DIRECTIONS TO THE ELK COUNTRY VISITOR CENTER

FROM WESTERN PA, travel east on Interstate 80 to the DuBois exit 101. At the exit ramp stop sign turn left onto Route 255 North towards Penfield. Travel north on Route 255 through the village of Penfield about 13 miles. Stay on Route 255 and go straight through the stop light. Travel to the village of Weedville about 8 miles. In Weedville turn right onto Route 555 East towards Driftwood/Benezette. Travel 9 miles to the village of Benezette. In Benezette turn left onto Winslow Hill Road. Winslow Hill Road makes an S curve past the Benezette Hotel and the Church. Continue up the hill about ¼ mile. The Elk Country Visitor Center entry located on the right, near our large sign. The address is 134 Homestead Drive (formerly 950 Winslow Hill Road), Benezette, PA 15821

FROM EASTERN PA, travel west on Interstate 80 towards DuBois to exit 111. At the stop sign on the exit ramp turn right onto Route 153 North towards the village of Penfield. At the stop light in Penfield turn right onto Route 255 North. Travel to the village of Weedville about 8 miles. In Weedville turn right onto Route 555 East towards Driftwood/Benezette. Travel 9 miles to the village of Benezette. In Benezette turn left onto Winslow Hill Road. Winslow Hill Road makes an S curve past the Benezette Hotel and the Church. Continue up the hill about ¼ mile. The Elk Country Visitor Center entry located on the right, near our large sign. The address is 134 Homestead Drive (formerly 950 Winslow Hill Road), Benezette, PA 15821

FROM NORTHERN PA, travel into the City of St. Marys. Take Route 255 South to the village of Weedville. Turn left onto Route 555 East. Take Route 555 East for 9 miles to the village of Benezette. In Benezette turn left onto Winslow Hill Road. Winslow Hill Road makes an S curve past the Benezette Hotel and the Church. Continue up the hill about ¼ mile. The Elk Country Visitor Center entry located on the right, near our large sign. The address is 134 Homestead Drive (formerly 950 Winslow Hill Road), Benezette, PA 15821

FROM SOUTHERN PA, travel to the City of Punxsutawney on Route 119. Take Route 119 North to DuBois. In DuBois turn right onto Route 255 North. Travel north on Route 255 through the village of Penfield about 13 miles. Stay on Route 255 and go straight through the stop light. Travel to the village of Weedville about 8 miles. In Weedville turn right onto Route 555 East towards Driftwood/Benezette. Travel 9 miles to the village of Benezette. In Benezette turn left onto Winslow Hill Road. Winslow Hill Road makes an S curve past the Benezette Hotel and the Church. Continue up the hill about ¼ mile. The Elk Country Visitor Center entry located on the right, near our large sign.
