USDA Employees

Proceed to the AgLearn (<http://www.aglearn.usda.gov/>) to login using your USDA credentials.

From the Dashboard, click on Learning and then select Find Learning and then scroll down to **Category**. Click on the down arrow and then select USDA, then FPAC, then NRCS, then **NRCS-NEDC-ONLINE** Scroll down or load more courses until you can choose the course name **Conservation Planning, Part 1 (or catalog number NRCS-NEDC-000019)**. Under course activities click on **Conservation Planning Part 1** to start the course.

District Employees with AgLearn account

Proceed to the AgLearn (<http://www.aglearn.usda.gov/>) to login using your USDA eAuthentication ID and password.

From the Dashboard, click on Learning and then select Find Learning and then scroll down to **Category**. Click on the down arrow and then select USDA, then FPAC, then NRCS, then **NRCS-NEDC-ONLINE** Scroll down or load more courses until you can choose the course name **Conservation Planning, Part 1 (or catalog number NRCS-NEDC-000019)**. You may contact Dan Ludwig and request an AgLearn account. Do not attempt to create a USDA eAuthentication or AgLearn account.

Once you receive an official USDA notification that your AgLearn account has been created, you will be prompted to create a USDA eAuthentication account. Once both accounts have been created, proceed AgLearn (<http://www.aglearn.usda.gov/>) to login using your USDA eAuthentication ID and password.
